
Enclosed is a copy of 2- pages of a 4-page *empty threat* dated 10-14-10 that I received from my post office box on 10-19-10 from the Department of Motor Vehicles to whom on September 9, 2010 I forwarded in satisfaction of violation A292896 to the Los Angeles Superior Court a Bank of America check #1917 for seven hundred fifteen dollars (usury) [\$715] thus rendering page 2 fill-in unnecessary.

Since mail goes every day and the check has not been returned the hitch here must be with the Superior Court for the County of Los Angeles which may be desirous of covering-up the responsibility the Honorable James C. Chalfant, judge of Superior Court of Los Angeles in case #BS 121 571: Esther M. Lofton v. Mark Ridley-Thomas, Supervisor, 2nd District County of Los Angeles-a writ of mandate- has to me pursuant to ARTICLE VI, §19, CC that is due on 10-21-10.

The threat is an *empty ones* since I have no intention of either relinquishing my driver's license or being caught driving my vehicle (license #4TED644) to give them the opportunity to impound my car.

I hope that your responsibility re apprehension of law breakers includes individuals in the Superior Court, County of Los Angeles which exists to prosecute law violators, not to violate the law.

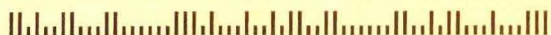
