Dear Mayor Villaraigosa:



An inspection has revealed that the property (Site Address) listed above is in violation of the Los Angeles Municipal Code (L.A.M.C.) as follows:

VIOLATION(S):

1. Electrical permit required.

You are therefore ordered to: Remove all electrical wiring and equipment which was installed without the required permits and return the electrical system to its original approved condition.

OR

Obtain the required electrical permit, expose concealed work and call for required inspections.

Code Section(s) in Violation: 93.0201, 93.0104, 12.21A.1.(a) of the L.A.M.C.

Location: Generator supplying power to electrical panel/wiring.

Comments: Portable generator connection to house electrical system must be of an approved method.

2. Noise level of fixed equipment exceeds the presumed ambient noise level by more than five decibels.

You are therefore ordered to: 1) Reduce the noise of the fixed or portable equipment to a permitted level.

Code Section(s) in Violation: 112.02(a), 12.21A.1.(a) of the L.A.M.C.

Location: Rear yard.

Comments: Portable generating device exceeds permitted noise level.
