RE: I'm forced to pay taxes to a government that is not instituted to uphold the Constitution for all citizens, [law abiding U.S. born blacks being inclusive](#).

Dear [President Barack Obama](#):

While the City of Los Angeles, specifically the LADWP, continues to [hold hostage all the earned retirement benefits](#) due yours truly, I have had to withdraw a substantial sum from earned City of Los Angeles deferred compensation savings for survival. I'm a longstanding taxpaying resident of the 10th Los Angeles City Council District, and 2nd Los Angeles County District.

Prior to receipt of earned City of Los Angeles Deferred Compensation savings, 20% in federal and 10% in state taxes, are levied against the distribution.

[Since January 19, 2011, I have been without LADWP supplied water at home because LADWP water utility workers removed LADWP's water meter, and installed a tamper-proof plug on the utility source, leaving me without a source of water to my residence.](#) I'm also a 30 year and of qualifying retirement age former employee of the LADWP, to which a substantial sum of my earned retirement benefits are being held hostage by the LADWP, while the LADWP threatens to discontinue [electric service to my residence](#). This is of court record in Los Angeles Superior Court Case 10K18049, the [Demurrer to Case 10K18049](#), and the proposed Judgment order before Judge Steven Kleifield, the "Judge of Court of Record".

As a better than 30 year property tax paying resident of the City and County of Los Angeles, the State of California, and/or Federal level of government, I'm forced to pay taxes to elected officials at the City, County, State, and/or Federal levels of government, who have no regard for the U.S. Constitution, the California Constitution, and/or the "rule of law".

Be it my [Dad, Leon E. Lofton, Jr., an honorably discharged disabled "Purple Heart" recipient combat infantry WWII Veteran draftee](#), my Mom, Mrs. Esther M. Lofton, other Lofton family members, Carl Steadman, yours truly, and/or other U.S. born black descendants of slaves we are violated repeatedly by the atrocities of a government gone awry, denied even basic "civil protection and services" time, and time again by past and present inept elected officials.

As for any support to raise taxes to reduce a City, County, State and/or Federal deficit, count me out, because for decades now, I don't receive nor do I benefit from even basic Constitutional protections, for the taxes I have paid, or currently pay.

During my youth I witnessed my Dad and Mom being arrested and jailed multiple times without just cause. My brothers, sisters, and I were placed on probation by incompetent [black probation officer, Elaine Reed](#). [My Dad is an honorably discharged recipient of a "purple heart" disabled draftee combat infantry veteran of WWII](#) whose [family was broken up for profit by incompetent Black social workers and/or other disgraceful individuals](#). On more than one occasion my sisters, brothers, and/or I, have been jailed or held hostage without just cause. [These un-American acts took place during the '60s, and 70's in jurisdictions to where the Democratic Party has been large and in charge](#), and elected Black leaders affiliated with the Democratic Party hold or have held elected office for decades. This is documented by long standing but unresolved Los Angeles Superior Court Cases [895188](#), [BC 385899](#).

I have a "[clean record](#)". I resent being punished by government for its' flagrant violations of the law that are truly un-American, and in violation of the U.S. and California Constitutions. With good reason, I have contempt for "inner-city" government institutions and elected officials who trash or ignore valid petitions for redress, to whom I'm forced to finance via taxation and/or who have contempt for the very individuals, specifically [Michael L. Lofton](#), and other law abiding citizens, who pay taxes. "[Theft by Court](#)" is yet another atrocity of government and egregious violation of the lawful rights of [Mr. Carl Steadman](#), also in a jurisdiction to where the Democratic Party has been large and in charge, and elected [Black leaders affiliated with the Democratic Party hold or have held elected office for decades](#).

With good reason, I intend to vote against, demand the impeachment, recall and/or firing of [President Barack Obama](#), Congresswoman [Karen Bass](#), [2nd District](#) LA County Supervisor [Mark Ridley Thomas](#), 8th District Councilman [Bernard Parks](#), 10th District City Councilman [Herb Wesson](#), other inept incumbents affiliated with the Democratic Party, inept Deputy Court Clerk [Delores Odom Stocks](#), who signed a default court judgment without authority at my expense, and other disgraceful individuals who have contempt for my rights, contempt for the U.S. Constitution and who have negated his or her first responsibility to uphold the U.S. Constitution, the 14th Amendment, "Equal Justice and Protection Under the Law", in behalf of law abiding U.S. born descendants of slaves, such as my parents, other Lofton family members, [Mr. Carl Steadman](#), [Mr. John Thompson](#), other law abiding individuals, and/or I, egregiously violated by government.

It's not too late for any of these individuals to redeem his or her character to truly make a constructive U.S. history first, to be removed from the "shameful elected official list", the primary requirement of redemption being to uphold the "Principles to which this Nation Stands" to competently serve U.S. born descendants of slaves.
